- Be able to store oats, rye, flax, buckwheat, and winter camelina
- Ability to process up to 2,500,000 bushels annually with a majority from August 1st to November 1st of the calendar year
- Flat storage capacity up to 120,000 sq ft with multiple loading docks for shipping and receiving
- On-site truck scale required
- Be within SD and NE preference given to locations along I-29, I-80, and I-90
- Be conducive for semis and various large equipment to enter/exit the property in all weather conditions
- 24-hour access to location for Millborn Seeds employees to ship and receive product
